#### 10. Neighbourhood Plan (standing item)

(1) Update on progress from Neighbourhood Plan Steering Group

Cllr Credicott advised the Steering Group had met with Wilts Council representative and the meeting was positive and helpful. Sophie David has been allocated as Officer and has supplied information which other groups have produced/used (which can be amended to suit our purposes); a 12 question document which may be of interest to councillors and an organisational flow-chart. Ashton Keynes PC and Kemble PC have been contacted as there may be an opportunity to share resources.

It was requested by Cllr Fraser that the name/organisation of the Planning Consultant who has been assisting the Group, be circulated to Councillors.

Councillors were requested to review the financial information in the Steering Group Constitution.

A Steering Group meeting will take place next week.

Locality Grant application is in process for £9,000 and this has been justified through the Planning Consultant Regarding the Site Allocation comments which are displayed on Wilts Council website, the Clerk confirmed that there is an issue with a residents comments being displayed as 'Parish Council' and the official Parish Council comments not being marked as such. Spatial Planning Department have been emailed to resolve this issue but no response to the email had been received.
